HOW TO CREATE A WORKABLE BUDGET

· Establish both short term and long term goals. Make it fun! Write down your goals whether it is paying off a bill, a dream vacation or maybe buying a home.



- Put it on paper; write down all your 📰 expenses and income. Not a paper person?
- There are many free apps to help you in your online mobile app store.
- Be realistic Make sure you include entertainment, fitness and children's activities. Special occasions such as Birthdays, Anniversaries and other special events.
- Don't forget to save! Strive to save 15% to 20% of your total income each month. Set up a special account to use for savings, perhaps a Christmas Club or Vacation Club account.
- Evaluate your status monthly Every budget evaluation can get you closer to achieving your goals. Start small and find new ways to save each month.

Small things like stopping to buy coffee each morning can add up to as much as \$40.00 per month. How much can you save by making your coffee at home? Another example is eating lunch out twice a week. While it may seem harmless, \$10.00 lunches can quickly add up to \$80.00 per month. Buying restaurant food and take-out orders instead of preparing your meals at home obviously cost more. Watch buying readymade food instead of taking time to prepare your meals the night before or in the morning means you may be spending extra money. Think about your habits and see what you can cut each month.

For the 2019 tax year, the maximum contribution you can make to a traditional or Roth IRA is \$6,000. This is an increase from the 2018 limit of \$5,500. This limit applies if you're under the age of 50. If you're over the age of 50, you may contribute up to \$7,000. You can no longer make regular contributions to a traditional IRA beginning with the year you turn 70 1/2. But once you open a Roth IRA, you can continue to make regular contributions to a Roth IRA and rollover contributions to a traditional IRA (or a Roth IRA) for as long as you live. There are many new tax laws going into effect. Talk to you tax specialist to make sure you are taking advantage of all possible tax deductions.

You can begin contributing to your IRA under 2019 limits on January 1, 2019. However, if you still haven't met your 2018 limit, you have until April 15, 2019 to max out.
